TERMS AND CONDITIONS

PART B

Important Terms and Definitions

B.1. DEFINITIONS

In this Policy, unless the context requires otherwise, the following words and expressions shall have the meaning ascribed to them respectively herein below:

Accident is defined as sudden, unforeseen and involuntary event caused by external and visible means.

Age shall be Age of Life Assured at Policy Commencement Date as at last birthday i.e. the Age in completed years and is recorded in the Policy Schedule based on the details provided by the Policyholder.

Basic Sum Assured means an absolute amount of benefit specified as such in the Policy Schedule and shall be equal to the Sum Assured on Maturity which is guaranteed to become payable on Policy Maturity Date, if the Life Assured has survived such date and all due Premiums have been received by the Company and in accordance with the terms and conditions of the Policy. Basic Sum Assured is dependent on the age of the Life Assured at inception of Policy, Premium and Policy Term chosen by the Policyholder.

Benefits mean the applicable benefits payable in accordance with Part C of the terms of this Policy.

Eligible Person means the Policyholder, including assignees under Section 38 of the Insurance Act, 1938 as amended from time to time, or Nominees under Section 39 of the Insurance Act, 1938 as amended from time to time, or proving executors of administration or other legal representatives, as per the applicable Regulations.

Additional Accidental Death Benefit means additional payout in case of accidental death which is equal to the Sum Assured on Death plus Guaranteed Additions accrued till date of death.

Date of Acceptance of Risk is the same as Policy Commencement Date.

Grace Period means the time granted by the Company from the due date for the payment of Premium without levy of any interest or penalty during which time the Policy is considered to be in force. The Grace Period so granted is 30 (thirty) days for annual premium payment modes from the respective Premium payment due date.

Guaranteed Additions (GA) means series of additions to the Benefits as specified in the Policy Schedule, calculated as a fixed percentage of the Sum Assured on Maturity, which accrue every year, payable to the Eligible Person as mentioned in part C of the terms of this Policy.

Guaranteed Surrender Value (GSV) means the value accrued after payment of at least 2 (two) full years' Premium, as mentioned in Part C. of the terms of this Policy.

Indebtedness means any unpaid Policy loans including accrued interest, Premiums, deductibles and any other amounts owed to the Company.

Lapse means a non-active life insurance contract on account of nonpayment of Premium within the Grace Period.

Life Assured shall mean the person named as mentioned in the Policy Schedule and on whose life the Policy has been taken in terms hereof.

Life Insurance Cover means the amount paid on death of the Life Assured as mentioned in part C of the terms of this Policy.

Loyalty Benefit is an amount payable only on maturity and as specified in the Policy Schedule, calculated as a fixed percentage of the Sum Assured on Maturity, payable to Policyholder as mentioned in part C of the terms of this Policy subject to his/her survival till the end of Policy Term.

Nominee means a person who is named as the Nominee in the Proposal Form or subsequently changed by an endorsement as per Section 39 of the Insurance Act, 1938 as amended from time to time, who has the right to give a valid discharge to the money secured under the Policy monies in case of death of the Life Assured before the maturity of the Policy. The holder of a Policy of life insurance on his own life may, when effecting the Policy or at any time before the Policy matures for payment, nominate a person or persons to whom the money secured by the policy shall be paid in the event of his/her death: Provided that, where any Nominee is a minor, it shall be lawful for the Policyholder to appoint any person in the manner laid down by the insurer, to receive the money secured by the policy in the event of death of the Life Assured during the minority of the Nominee.

Policy means the contract of insurance entered into between the Policyholder and the insurer as evidenced by the Policy Document.

Policy Commencement Date/ Date of Inception of the Policy means the Date, Month, and Year the Policy comes into effect and is specified as such in the Policy Schedule.

Policy Document means the Policy Schedule, the signed Proposal Form, Annexure and any other attached endorsements or supplements together with all addendums and includes necessary documents.

Policyholder shall mean the owner of this Policy and is referred to as the proposer in the proposal form and is named as such in the Policy Schedule.

Policy Maturity Date means the date of completion of the Policy Term as specified in the Policy Schedule.

Policy Schedule means the Schedule issued by the Company that sets out the details of this Policy and is attached to and forming part of this Policy.

Policy Term means the tenure of this Policy during which the contractual Benefits are payable and is specified as such in the Policy Schedule.

Policy Year means a period of twelve (12) consecutive months starting from the Policy Commencement Date and ending on the day immediately preceding the following Policy anniversary date and each subsequent period of twelve (12) consecutive months thereafter.

Premium means the contractual amount payable by the Policyholder in a Policy Year on the due date as set out in the Policy Schedule to secure the Benefits under this Policy. Applicable tax and other levies if any are payable in addition.

Premium Payment Term (PPT) means the period in years during the Policy Term in which Premiums are payable by the Policyholder under the Policy, as specified in the Policy Schedule.

Regulations mean the laws and Regulations in effect as amended from time to time and applicable to this Policy, including without limitation the Regulations and directions issued by the Insurance Regulatory and Development Authority of India (IRDAI) from time to time. The applicable Regulation shall form a part and parcel of the terms and conditions, and the terms and conditions shall be read along with the Regulation.

Revival means restoration of the Policy, which was discontinued due to non-payment of the Premium, by the Company with all the Benefits mentioned in the terms and conditions, with or without Rider Benefits, if any, upon receipt of all the Premiums due and other charge/late fee, if any, as per the terms and conditions of the Policy, upon being satisfied as to the continued insurability of the Life Assured/Policyholder on the basis of the information, documents and reports furnished by the Policyholder.

Special Surrender Value (SSV) means the value that may accrued after payment of at least 2 (two) full years' Premiums, as mentioned in Part C. of the terms of this Policy.

Sum Assured on Death means an absolute amount of benefit which is guaranteed to become payable on the event of death of the Life Assured in accordance with the terms and conditions of the Policy and is specified as such in the Policy Schedule or such amount as may be endorsed on the Policy.

Sum Assured on Maturity is defined as the amount equal to Basic Sum Assured which is guaranteed to become payable on Policy maturity date, if the Life Assured has survived such date and all due Premiums have been received by the Company and in accordance with the terms and conditions of the Policy.

Surrender means complete withdrawal/termination of the entire Policy by the Policyholder in accordance with the terms of the Surrender.

Surrender Value means an amount, if any, that becomes payable in case of Surrender in accordance with the terms and conditions of the Policy.

"We", "Us", "Our" and **"Company"** refers to Exide Life Insurance Company Limited.

"You", and **"Your"** refers to the Policyholder.

PART C
Product Core Benefits

BENEFITS PAYABLE UNDER THIS POLICY

C.1. Life Insurance Cover: Subject to terms and conditions of this Policy and the Policy remaining in full force and effect, in the event of death of the Life Assured before Policy Maturity Date, the Company shall pay Life Insurance Cover to the Eligible Person subject to the waiting period. The Policy will terminate on payment of Life Insurance Cover.

Life Insurance Cover under this Policy is equal to Sum Assured on Death plus accrued Guaranteed Additions till date of death plus Additional Accidental Death Benefit, if applicable.

The Life Insurance Cover is payable to the Eligible Person after deduction of any Indebtedness which is unpaid as on the date of death.

C.1.1. Sum Assured on Death: is defined as the highest of

- 10 times the Annualized Premiums or
- Sum Assured on Maturity or
- Absolute amount assured to be paid on death or
- 105% of total Premium paid till date of death

Where Absolute amount assured to be paid on death shall be equal to the Basic Sum Assured chosen at the inception of Policy, and

Annualized Premium shall be the premium payable in a year chosen by the policyholder, excluding underwriting extra premiums, loadings for modal premiums, if any.

C.1.2 Waiting Period: It is a period of first 90 days from the Date of Acceptance of Risk, applicable at initial purchase of the Policy and not on revival of the Policy In case of death (other than due to accident) of Life Assured during waiting period, only 100% of Premium received excluding taxes, if any, shall be payable to the Eligible Person. Waiting period shall not be applicable for accidental death.

C.1.3. Additional Accidental Death Benefit: In case of accidental death the Policy pays additional Accidental Death Benefit, which is, equal to Sum Assured on Death plus Guaranteed Additions accrued till date of death.

C.2. Maturity Benefit: Subject to the terms and conditions of this Policy and the Policy remaining in force and effect on the Policy Maturity Date, the Company shall pay to the Eligible Person the following Benefits on Policy Maturity Date:

C.2.1. Sum Assured on Maturity under this Policy

C.2.2. Guaranteed Additions (GA)

C.2.3. Loyalty Benefit (LB)

C.3. Guaranteed Additions (GA) and Loyalty Benefit (LB): The plan offers Guaranteed Additions as a percentage of Sum Assured on Maturity. The Guaranteed Additions are calculated at a simple rate for each completed Policy Year. The GA are accrued and credited to the Policy at the end of each Policy Year over the policy term and shall be payable on death or maturity or surrender.

Loyalty Benefit is a one-time benefit payable on the Policy Maturity Date. The payment of Loyalty Benefit is subject to receipt of all due premiums by the Company and Policy being in force. The Loyalty Benefit will be calculated as a percentage of Sum Assured on Maturity.

The GA rate and LB rate based on the opted Policy Term and Premium are as follows:

C.4. Payment of Premiums: The Policyholder shall pay to the Company the Regular Premium in such frequency on or before the due date for Premium payment as specified in the Policy Schedule or within the Grace Period as mentioned in Part C.7 to secure the applicable Benefits under this Policy. During the Grace Period, the Policy is in full force and eligible for all Benefits under the terms of the Policy. If any Regular Premium is received before the due date for Premium payment, the Company will keep such amount in suspense account and adjust such sum towards Regular Premium on the applicable due date.

C.5. Payment of Benefits

C.5.1. Payment of the Benefits under this Policy shall be subject to deduction of any Indebtedness arising out of outstanding Policy loans including interest due on such loans, unpaid Premium, deductibles and any other amounts owed to the Company.

C.5.2. Payment of all the Benefits as shown in the Policy Schedule shall be subject to receipt of proof by the Company to its satisfaction;

C.5.2.1. of the Benefits having become payable as set out in this Policy; and

C.5.2.2. of the title of the person or persons claiming the Benefits; and

C.5.2.3. of the correctness of the Age of the Life Assured as stated in the Proposal, if not previously admitted.

C.6. Mode of payment of Benefits

C.6.1. All Benefits and other sums under this Policy shall be payable in the manner and currency allowed/permitted under the Regulations and shall be payable by NEFT, account payee cheque or other permissible modes.

C.6.2. The Company shall pay the applicable Benefits and other sums payable under this Policy. Any discharge given by the Eligible Person, or by any person authorized by the Eligible Person in writing in respect of the Benefits or the sums payable under this Policy shall constitute a valid discharge to the Company in respect of such payment. The Company's liability under the Policy shall be discharged by such payment and the Company shall not be required to see the utilization of the monies so paid.

C.6.3. Apart from the Benefits mentioned hereinabove in part C the Company shall not be liable to pay any other Benefits to the Eligible Person.

C.7. Grace Period: A Grace Period of thirty (30) days from the Premium payment due date will be allowed for payments of each Premium. The Regular Premiums are payable on the due date for payment and in any case not later than the Grace Period. During the Grace Period, the Policy shall continue to be in force for availing the Life Insurance Cover. Any unpaid Premium is deductible from the Benefits that may accrue during the Grace Period.

PART D

Policy Servicing Related Aspects

D.1. Free Look Provisions: The Policyholder shall have a period of 15 days (30 days if the Policy is sourced through Distance Marketing[#]) from the date of receipt of the Policy Document to review the terms and conditions of this Policy and if the Policyholder disagrees with any of the terms and conditions, he/she has the option to return the Policy stating the reasons for the cancellation upon which the Company shall return the Premium paid subject to deduction of a proportionate risk Premium for the period of insurance cover in addition to the expenses incurred on medical examination (if any) and the stamp duty charges. All Benefits and rights under this Policy shall immediately stand terminated on the cancellation of the Policy.

[#]Distance Marketing includes solicitation through all modes other than in person.

D.2. Revival of the Policy:

D.2.1. Subject to the approval of the Company and the prevailing board approved underwriting policy, this Policy, if lapsed, may be revived for full Benefits before the Policy Maturity Date but within two years from the due date for payment of the first unpaid Premium provided that;

D.2.1.1. This Policy has not been surrendered for cash;

D.2.1.2. No claim has arisen under this Policy.

D.2.1.3. Where required by the Company, a written application for Revival is received from the Policyholder by the Company, together with evidence of insurability and health of the Life Assured, to the satisfaction of the Company; and

D.2.1.4. All amounts necessary to revive this Policy including all arrears Premiums together with payment of late fees calculated at such interest rate prevailing at the time of the payment as levied by the Company.

D.2.2. Notwithstanding anything to the contrary contained elsewhere in this Policy, the Company reserves the right to revive the lapsed Policy either on its original terms and conditions or on such other or modified terms and conditions as the Company may specify or to reject the Revival. If needed the Company may refer it to its medical examiner in deciding on Revival of lapsed Policy. Subject to the provisions of Clauses D.2.1 above, the Revival shall come into effect on the date when the Company specifically communicates it in writing to the Policyholder.

D.3. Non-Forfeiture options upon Non-Payment of Premiums:

If at least 2 full years' Premium have not been paid, the Policy will Lapse until the Policy is revived for full Benefits within two years from the first unpaid Premium due date. No Benefits will be paid to the Policyholder or the Eligible Person if the Policy is in Lapse stage.

If at least two full years' Premiums have been paid, and if any subsequent Premium due has not been paid, the Policyholder will be eligible for reduced paid-up value as explained in section D.3.1. and Surrender Value as explained in section D.3.2.

D.3.1. Reduced Paid-up Value

If at least 2 full years' Premium has been paid and further Premiums are unpaid and the Policy is not surrendered, the Policy will acquire the status of reduced paid up on the date of expiry of Grace Period up till the Policy is revived for full Benefits. Once the Policy attains the status of reduced paid up, the Life Insurance Cover will be reduced as per the formula mentioned below:

$$\text{Reduced Paid - up Life Insurance Cover} = \frac{\text{Number of premiums paid}}{\text{Total Number of premiums payable}} \times (\text{Sum Assured on Death} + \text{Accrued Guaranteed Additions})$$

During the Reduced paid-up state of the Policy, the Reduced Paid-up Life Insurance Cover will be paid on death of Life Assured.

Additional Accidental Death Benefit in case of Reduced Paid-up Death Benefit shall be calculated as per the formula mentioned below:

$$\text{Reduced Paid - up Additional Accidental Death Benefit} = \frac{\text{Number of premiums paid}}{\text{Total Number of premiums payable}} \times (\text{Sum Assured on Death} + \text{Accrued Guaranteed Additions})$$

Reduced paid-up maturity benefit will be calculated as per the formula mentioned below:

$$\text{Reduced Paid - up Maturity Benefit} = \frac{\text{Number of premiums paid}}{\text{Total Number of premiums payable}} \times \left(\frac{\text{Sum Assured on Maturity} + \text{Accrued Guaranteed Additions} + \text{Loyalty Benefit}}{\text{100}} \right)$$

Guaranteed Additions shall accrue till the date of death in case of death or Policy Maturity Date in case of maturity.

Instead of continuing with the reduced paid-up policy one can surrender the policy.

D.3.2. Surrender of the Policy: If at least two full year's Premium is paid the Policy can be surrendered. The Policy cannot be surrendered after the death of the Life Assured. Upon payment of the Surrender Value, the Policy shall stand terminated with no further Benefits payable under the Policy and the Company shall be relieved and discharged from all obligations under this Policy thereafter.

The Surrender Value is payable immediately on Surrender and the Policy shall be terminated upon payment of Surrender Value.

In the event of non-payment of 2 full years premiums, the policy shall lapse and no surrender benefit shall be payable.

D.3.2.1.Surrender Value: The Policy acquires a Surrender Value which is higher of Guaranteed Surrender Value or Special Surrender Value (SSV).

D.3.2.2.Guaranteed Surrender Value (GSV): If at least two full years' Premium has been paid, the Policy acquires a Guaranteed Surrender Value. The Guaranteed Surrender Value will be the sum of the following:

- a) GSV as a percentage of Premiums paid: GSV factor 1 multiplied by the total amount of Premiums paid excluding the Premium for extra mortality rating if any, and
- b) GSV as a percentage of accrued Guaranteed Additions and applicable loyalty benefit: GSV factor 2 multiplied by the total value of accrued Guaranteed Additions and loyalty benefit applicable to the Policy.

The Guaranteed Surrender Value factors with respect to the Policy Term are tabulated as below:

D.3.2.3.Special Surrender Value (SSV): The Policy shall acquire a Special Surrender Value if all the Premiums have been paid for atleast two consecutive years. The Special Surrender Value will be quoted only on receipt of a Surrender request which shall be determined by the Company from time to time and is not guaranteed.

The Surrender Values and Non-forfeiture provisions apply only to the Base Policy mentioned in the Schedule and not to any Riders.

D.4. Policy Loan: Any time after two full years' Premiums have been paid, and if any Surrender Value is available under the Policy, the Policyholder may obtain a loan on the sole security of the Policy and on its proper assignment to the Company. The maximum amount of loan that will be advanced at any one time or more than one time shall not exceed 80% of the available Special Surrender Value and provided that the amount of the loan is not less than INR 1000/-. The current rate of interest on the loan is 8.25% p.a. compounded semi-annually. The rates of interest payable on the loan and the other terms and conditions of the loan shall be as determined by the Company from time to time and will be subject to IRDAI's approval.

The loan interest rate is set as per the formula below on 1st April every year:

Higher of (Bank rate fixed by RBI as on 1st April + 2%, Pricing interest rates +1%, best estimate rate used in setting of valuation rate). The rate is reviewed annually and is rounded to nearest 25 basis points.

All loans within the permissible limits will be the difference between maximum permissible loan amount less any outstanding loan with accumulated interest, if any. All outstanding loan and interest thereon shall be deducted from any Benefits payable under the Policy. For in-force or fully paid-up policies, if at any point of time, the loan along with outstanding accrued interest exceeds the value of benefits payable under the Policy, the Policy will be not be forfeited. Except in case of in-force or fully paid-up policies, if at any point of time, the loan along with outstanding accrued interest exceeds the value of Benefits payable under the Policy, the Policy will be foreclosed and no Benefits will be payable. Any payment made by the Policyholder in the Policy will first be utilized to repay the Policy Loan and then for any Premiums due, if any. The minimum amount of Policy Loan that can be repaid at every instance shall be INR 500 or total outstanding loan plus interest whichever is lower.

PART E

All the applicable Charges, Fund Name, Fund Options etc. (Applicable especially for ULIP Policies)

E.1. Not Applicable as this is a Non-linked individual product.

PART F
General Terms and Conditions

F.1. Exclusions

F.1.1 Suicide: If the Life Assured commits suicide for any reason, while sane or insane, within one year from the Date of Inception of the Policy or within one year from the date of Revival of the lapsed Policy, as the case may be, the Policy shall terminate with immediate effect and the Company will not be liable to pay the Benefits under the Policy other than what is specified below:

- If death occurs within one year from the Date of Inception of the Policy: 80% of Premium paid provided the Policy is in force shall be paid to the Eligible Person.
- If death occurs within one year from date of revival, Higher of 80% of Premiums paid or Surrender value as available on the date of death and the Policy terminates

F.1.2. Waiting Period: It is a period of first 90 days from the Date of Acceptance of Risk, applicable at initial purchase of the Policy and not on revival of the Policy. In case of death (other than due to accident) of Life Assured during waiting period, only 100% of Premium received excluding taxes, if any, shall be payable to the Eligible Person. Waiting period shall not be applicable for accidental death. It shall not be applicable after the revival of the Policy.

F.1.3. The conditions for Accidental Death and related exclusions:

Accidental Death: For the accident death benefit to be payable, death due to the accident must occur within 180 days of the accident. The cover with regard to Additional Accidental Death Benefit will commence on the date of life assured attaining age 18 years.

Injury: means the accidental physical bodily harm excluding illness or disease solely and directly caused by external, violent and visible and evident means which is verified and certified by a registered independent medical practitioner.

No accidental death benefit is payable if death is caused directly or indirectly by any of the following:

1. Death due to infection or disease unless the infection or disease occurs due to injuries sustained due to accident.
2. Drug Abuse: Member under the influence of Alcohol or solvent abuse or use of drugs except under the direction of a registered independent medical practitioner.
3. Suicide or Self-inflicted Injury: Intentional self- Inflicted injury.
4. Criminal acts: Member involvement in Criminal and/or unlawful acts with criminal intent.
5. War and Civil Commotion: War, invasion, hostilities, (whether war is declared or not), civil war, rebellion, revolution or taking part in a riot or civil commotion.
6. Nuclear Contamination: The radioactive, explosive or hazardous nature of nuclear fuel materials or property contaminated by nuclear fuel materials or accident arising from such nature.
7. Aviation: Member participation in any flying activity, other than as a passenger in a commercially licensed aircraft.
8. Hazardous sports and pastimes: Taking part or practicing for any hazardous hobby, pursuit or any race not previously declared and accepted by the Company.
9. Physical handicap or mental infirmity existing at the time of insurance proposal and not disclosed at the time of proposal.

The above mentioned first 8 exclusions shall not be applicable in case of payment of basic Death Benefit. Being Physically handicapped/challenged and not disclosed at the time of insurance proposal then the Eligible Person will not be entitled for any benefit including the Basic Death Benefit subject to Section 45 of the Insurance Act 1938 as amended and applicable from time to time.

F.2. Fraud, Misrepresentation and forfeiture: In issuing this Policy, the Company has relied on, and may rely on, accuracy and completeness of the information provided by the Proposer/Life Assured and any other declarations or statements made or as may be made hereafter, by the Policyholder/Life Assured.

In case of fraud or misrepresentation, the Policy shall be cancelled in accordance with provisions of Section 45 of the Insurance Act, 1938 as amended from time to time..

[A Leaflet containing the simplified version of the provisions of Section 45 is enclosed as Annexure I for reference]

F.3. Admission of Age: The Age of the Life Assured has been admitted on the basis of the declaration made by the Policyholder / Life Assured in the Proposal form and/or in any document/statement based on which this Policy has been issued. If the Age of the Life Assured is found to be different from that declared, the Company may, adjust the Premiums and/or the Benefits under this Policy and/or recover the applicable balance amounts, if any, as it deems fit. This Policy shall however become void from commencement, if the Age of the Life Assured at the Policy Commencement Date is found to be higher than the maximum or lower than the minimum entry Age that was permissible under this Policy at the time of issue and the Company shall return the Premiums paid subject to deduction of expenses incurred on the stamp duty charges.

F.4. Assignment: Assignment should be in accordance with provisions of Section 38 of the Insurance Act 1938 as amended from time to time.

[A Leaflet containing the simplified version of the provisions of Section 38 is enclosed as Annexure II for reference].

F.5. Nomination: Nomination should be in accordance with provisions of Section 39 of the Insurance Act 1938 as amended from time to time.

[A Leaflet containing the simplified version of the provisions of Section 39 is enclosed as Annexure III for reference]

F.6. Review, revision: The Company reserves the right to review, revise, delete and/ or alter any of the terms and conditions of this Policy, including without limitation the Benefits, the Premiums with the prior approval of IRDAI.

F.7. Release and discharge: The Policy will terminate automatically on payment of the Surrender Value, Life Insurance Cover, Maturity Benefit, on Lapse of the Policy or on the happening of the events that are covered under this Policy, and the Company will be relieved and discharged from all obligations under this Policy thereafter.

F.8. Taxes, duties and levies and disclosure of information: This Policy, and the Benefits and the Surrender Value payable under this Policy shall be subject to the Regulations, including taxation laws in effect from time to time. All taxes, duties or levies or other taxes (collectively "Taxes") as may be imposed now or in future by any authority on the Premiums, charges and Benefits shall be borne and paid by the Policyholder or the Eligible Person, as the case may be or deducted by the Company from the Premium received or Benefits payable. The Premium and other sums payable under or in relation to the Policy do not include the Taxes. The persons receiving the Benefits shall be solely liable for complying with all the applicable provisions of the Regulations, including taxation laws, and payment of all applicable Taxes. In any case where the Company is obliged to account to the revenue authorities for any Taxes applicable to this Policy or the Benefits payable under this Policy, the Company shall be entitled to deduct such Taxes from any sum payable under this Policy, and deposit the amount so deducted with the appropriate governmental or regulatory authorities. In any case where the Company is obliged to disclose to the revenue or other regulatory authorities any information concerning the Policy, including information concerning the Premium and the Benefits under this Policy, the Company shall be entitled to disclose the required information to the appropriate governmental or regulatory authorities.

F.9. Notice by the Company under the Policy: Any of the notices required to be issued in terms of this Policy may be issued, either by issuing individual notices to the Policyholder, including by electronic mail and/or facsimile, or by issuing a general notice, including by publishing such notices in newspapers and/or on the Company's website.

Please communicate any changes in your mailing address or any other communication details as soon as possible. This will enable us to serve you better.

F.10. Entire Contract: This Policy comprises of the terms and conditions set forth in this Policy Document, the Policy Schedule, and the endorsements, if any, made on or applicable to this Policy, which shall form an integral part and the entire contract evidenced by this Policy. The liability of the Company is at all times subject to the terms and conditions of this Policy and the endorsements made from time to time.

F.11. Risk Factors:

a) This is a Non- Linked, Non-Participating Life Insurance Product.

b) Exide Life Insurance Company Limited is only the name of the Insurance Company and the name of the product does not in any way indicate the quality of the product, its future prospects or returns.

F.12. Governing Law and Jurisdiction: This Policy shall be governed by and interpreted in accordance with the laws of India. All actions, suits and proceedings under this Policy shall be subject to the exclusive jurisdiction of the courts in India.

F.13. Grace Period: A Grace Period of thirty (30) days from the Premium payment due date will be allowed for payments of each Premium. The Regular Premiums are payable on the due date for payment and in any case not later than the Grace Period. During the Grace Period, the Policy shall continue to be in force for availing the Life Insurance Cover. Any unpaid Premium is deductible from the Benefits that may accrue during the Grace Period. If the Premiums due are not paid within the Grace Period, the Policy will be eligible for Non-Forfeiture options.

F.14. Requirements for maturity claims and death claims: In the event of a claim for Maturity Benefit or Life Insurance Cover arising under this Policy, the Eligible Person shall intimate to the Company in writing of the claim and provide the following documents to the Company to enable the Company to process the claim:

F.15.1. In case of maturity claims:

- (i) Original Policy Document; and
- (ii) Discharge Form
- (iii) Self-attested ID Proof, and
- (iv) Bank account details along with IFSC code (payment would be made vide NEFT only) in case there is a change in the bank details already provided.

F.15.2. In case of death claims, except death claims arising out of accidents or unnatural deaths

- (i) Death Certificate, in original, issued by the competent authority;
- (ii) Policy Document, in original;
- (iii) Identification proof (bearing photo) of person receiving the Benefit and the Life Assured.
- (iv) Medical treatment records (discharge summary / death summary, investigation reports, etc.) if Life Assured has taken treatment for illness leading to his/her death.
- (v) Bank account details of the claimant along with IFSC code (payment would be made vide NEFT only)

F.15.3. In case of death claims arising out of accidents or unnatural deaths

- (i) Death Certificate, in original, issued by the competent authority;
- (ii) Policy Document, in original;
- (iii) Identification proof (bearing photo) of person receiving the Benefit and the Life Assured.
- (iv) First Information Report, Inquest and the Final Investigation Report thereof, duly attested by concerned jurisdictional Police Official.
- (v) Post Mortem Report duly attested by the concerned officials.
- (vi) Bank account details of the claimant along with IFSC code (payment would be made vide NEFT only)

Notwithstanding anything contained in Clause F.15.2 and F.15.3 above, depending upon the cause or nature of the claim, the Company reserves the right to call for any other and/or additional documents or information, including documents/information concerning the title of the person claiming the Life Insurance Cover under this Policy, to the satisfaction of the Company, for processing of the claim.

The claim is required to be intimated to the Company within a period of 180 days from the date of death, to treat the same as a valid claim. However, delay in intimation of claim or submission of documents for the reasons beyond the control of the insured/claimant may be condoned by the Company.

F.16 Issuance of Duplicate Policy: In the event if the Policyholder loses/misplaces /destroys the original Policy bond, the Policyholder shall immediately inform the Company, the Company after obtaining satisfactory evidence shall issue duplicate Policy by collecting necessary charges not exceeding ₹250 and on such conditions as decided by the Company and after completing procedural compliances.

Level 4

Appeal before the Insurance Ombudsman (As per Rule 14 (3) of Insurance Ombudsman Rules 2017)

In case the Eligible Person has a grievance against insurer and is not satisfied with the decision/resolution of the Company, the Eligible Person may make a complaint in writing to the Insurance Ombudsman within whose territorial jurisdiction the branch or office of the insurer complained against or the residential address or place of residence of the complainant is located.

The complaint shall be in writing, duly signed by the complainant or through his legal heirs, nominee or assignee and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against whom the complaint is made, the facts giving rise to the complaint, supported by documents, the nature and extent of the loss caused to the complainant and the relief sought from the Insurance Ombudsman.

No complaint to the Insurance Ombudsman shall lie unless :

(a) the complainant makes a written representation to the insurer named in the complaint and :

(i) either the insurer had rejected the complaint; or

(ii) the complainant had not received any reply within a period of one month after the insurer received his representation; or

(iii) the complainant is not satisfied with the reply given to him by the insurer;

(b) The complaint is made within one year :

(i) after the order of the insurer rejecting the representation is received; or

(ii) after receipt of decision of the insurer which is not to the satisfaction of the complainant;

(iii) after expiry of a period of one month from the date of sending the written representation to the insurer if the insurer named fails to furnish reply to the complainant.

The Ombudsman shall be empowered to condone the delay in such cases as he may consider necessary, after calling for objections of the insurer against the proposed condonation and after recording reasons for condoning the delay and in case the delay is condoned, the date of condonation of delay shall be deemed to be the date of filing of the complaint, for further proceedings under these rules.

No complaint before the Insurance Ombudsman shall be maintainable on the same subject matter on which proceedings are pending before or disposed of by any court or consumer forum or arbitrator.

ANNEXURE - I

Section 45 – Policy shall not be called in question on the ground of misstatement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time are as follows:

01. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 years from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policywhichever is later.

02. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policywhichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
 - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
 - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / claimant can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such misstatement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Policyholder, if alive, or claimant.
06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
07. In case repudiation is on ground of misstatement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.
08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.

ANNEXURE - II

Section 38 - Assignment and Transfer of Insurance Policies:

Provisions regarding assignment or transfer of a policy in terms of Section 38 of the Insurance Act, 1938, as amended from time to time are as follows:

01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
 - a. not bonafide or
 - b. not in the interest of the Policyholder or
 - c. not in public interest or
 - d. is for the purpose of trading of the insurance policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of Policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
 - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
 - b. where the transfer or assignment is made upon condition that
 - i. the proceeds under the policy shall become payable to Policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
 - ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
 - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
 - b. may institute any proceedings in relation to the policy
 - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act 2015 shall not be affected by this section.

ANNEXURE - III

Section 39 – Nomination by Policyholder

Provisions regarding nomination of a policy in terms of Section 39 of the Insurance Act, 1938, as amended from time to time are as follows:

01. The Policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
02. Where the nominee is a minor, the Policyholder may appoint any person to receive the money secured by the policy in the event of Policyholder's death during the minority of the nominee. The manner of appointment is to be laid down by the insurer.
03. Nomination can be made at any time before the termination of the policy.
04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bona fide payment is made to the person named in the text of the policy or in the registered records of the insurer.
07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the Policyholder of having registered a nomination or cancellation or change thereof.
09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
11. In case of nomination by Policyholder whose life is insured, if the nominees die before the Policyholder, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
13. Where the Policyholder whose life is insured nominates his
 - a. Parents, or
 - b. Spouse, or
 - c. Children, or
 - d. Spouse, and children
 - e. or any of themthe nominees are beneficially entitled to the amount payable by the insurer to the Policyholder unless it is proved that Policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.
14. If nominee(s) die after the Policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Act 2015.
16. If Policyholder dies after termination but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Amendment) Act 2015, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.
